#### Sanction Catalogue

### (In continuation to the operating policy of USOCA:

USOCA, categorized Non-Compliance as major, minor and irregularity (sanction) based on the severity and their consequences major, minor and sanction can be disabled as following: -

- Minor Non-Compliance: Offences that do not affect the integrity of the accreditation process and are rectifiable. Examples of such minor offences include but are not limited to failure; to submit information on time, improper document control, internal audit and management review not carried out as per requirement.
- Minor issues in operation i.e. record keeping, indicate no system failure or implementation of the organic system plan. Certification can be granted or continued before correction, but correction must occur during a specified period that can be no later than prior to the next inspection or annual update or as per USOCA Policy the minor NC will be upgraded to Major NC if not rectified before next inspection.

Major Non-Compliance: Offences that affects the integrity of the NPOP in general and Certification process in particular. Examples of such major non-compliances include, but are not limited to Non-compliance with organic standard, knowingly provide false information/documents misrepresentation as to certification status, repetition of same non conformities, failure to rectify such non compliances etc.

Irregularity/sanction can be imposed in case, when the non-compliance affects the integrity of organic and in conversion and operators failed to take proper corrective measures and to control the damage as per USOCA inspection audit report than USOCA will impose sanctions on the operator based on non-conformity during inspections/investigations etc. as per their sanction catalogue.

The sanctions to be imposed shall be depend on the nature, degree and extent of such nonconformity.
